## WHAT DOES TRI COUNTIES BANK DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect, and share depend on the product or service you have with us. This information can include:  • Social Security number and payment history  • Transaction or loss history and account transactions  • Overdraft history and wire transfer instructions  When you are <i>no longer</i> our customer, we continue to share your information as described in this notice
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Tri Counties Bank chooses to share; and whether you can limit this sharing.

How does Tri Counties Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.			
How does Tri Counties Bank collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>Open an account or pay your bills</li> <li>Apply for a loan or give us your contact information</li> <li>Make a wire transfer</li> <li>We also collect your personal information from others such as credit bureaus, affiliates or other companies.</li> </ul>			
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for non-affiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing. See below for more information about your rights under state law.</li> </ul>			
Definitions				
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  • Tri Counties Bank does share with our affiliates			
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • Tri Counties Bank does not share with non-affiliates so they can market to you			
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  • Tri Counties Bank doesn't jointly market.			
Other Important Information				
California Residents	Under California law, we will not share information we collect about you with companies outside of Tri Counties Bank, unless the law allows. For example, we may share information with your consent to service accounts, or to provide benefits you are entitled to. We will limit this sharing to the extent required by California law.
